Internal rules of procedure for visitors of the sports complex "333"

1. General Provisions:

- 1.1. The present regulations set procedure to be observed by any visitor (hereinafter – Visitor) of the company SIA "Baltic Ring 333" and its private area (hereinafter – 333), such Visitors being customers, participants or organizers of a competition/event, spectators and other persons; Rules shall apply within the entire area of 333;
- 1.2. Race tracks and facilities within the area of 333 are objects of increased danger, in which the organizer bears full responsibility for the training process and its safety during training and competitions;
- 1.3. **Video surveillance is carried out in the territory of the 333 complex, the purpose of which is the prevention or detection of criminal offenses in connection with the protection of property and the protection of vital interests of individuals;**
- 1.4. While in the territory of 333 during a public event, the Visitor is informed and will not raise any claims against photos taken during a public event and video that companies capture during the event. 333 or the lessee of the territory is entitled to use these materials for marketing purposes and for archival storage;
- 1.5. Anyone can get familiarized with the rules on the website: <https://333.lv/>;
- 1.6. These terms and conditions are not considered an offer to the visitor to enter into a contract. The contract is concluded by purchasing a ticket or making a payment for equipment rental. The duties of the visitor specified in the regulations are binding and also apply to those persons who are actually in the 333 territory without a ticket or before purchasing a ticket or after its expiration. If the person is actually located in the territory of 333, it is recognized that the person has accepted these rules and recognized them as binding;
- 1.7. Visitors under the age of 18 are allowed to be in the 333 territory only under the continuous supervision of parents or authorized representatives over the age of 18;
- 1.8. The right to use inventory in the territory of 333 belongs to a natural person who has reached at least 12 years of age. Minors under the age of 12 may use the inventory only under the direct supervision of an adult. Certain types of inventory and parts of the territory may be subject to separate age restrictions.
- 1.9. The right to use territory 333 belongs to a legal entity in accordance with the price list of the track, if a cooperation agreement has been concluded or an invoice has been submitted, which determines the time and extent of use of territory 333.
- 1.10. Paid services are provided in accordance with the price list of 333;
- 1.11. In case of special events and circumstances, visitors' access to the 333 territory may be denied or restricted.

2. Responsibilities of the visitor:

- 2.1. It is the duty of every visitor to the 333 territory to familiarize him/herself with these Rules before visiting or taking part in events. The rules are binding for all 333 visitors. Ignorance of them does not release the visitor from responsibility in cases of committing violations, if the visitor has been familiarized with the rules or had the opportunity to familiarize him/herself with the rules;
- 2.2. Any Visitor shall strictly follow instructions of the 333 staff, the persons responsible for the event, the security guards and the requirements of the police officers;
- 2.3. If the Visitor is a 333 customer who uses one of the services provided by 333, then all activities related to the specific service are performed by the Visitor in strict compliance with the requirements set out in the documentation binding to the relevant service, the service operating rules;
- 2.4. 333 tracks, other sports infrastructure structures, marked bicycle tracks and running trails, established recreation areas and other objects may be used only for their intended purposes;
- 2.5. If the Visitor is the organizer of the competition/event, then the Visitor strictly complies with the requirements stipulated in the mutual agreement with 333 and is responsible for its guests, customers, event visitors, participants. During the events, event organizers must ensure compliance with these Regulations, the Law on Safety of Public Entertainment and Festive Events [*Publisku izklaides un svētku pasākumu drošības likums*], as well as all other binding regulatory acts and public order. During the event, event organizers are responsible for the safety of participants and visitors;
- 2.6. If the Visitor is a participant of the competition/event, then the Visitor strictly follows the instructions of the organizer of the competition/event;
- 2.7. In addition to provisions of clauses 2.1. – 2.4., all 333 Visitors have the following responsibilities:
 - 2.7.1. to be in the part or parts of the 333 territory corresponding to Visitor's status;
 - 2.7.2. to observe ethical norms while in a public place, including not using profanity and picking up trash left behind;
 - 2.7.3. to treat property of 333 with care;
 - 2.7.4. if there are any questions, problems, ambiguities related to the operation of 333 – the person should ask the 333 staff in order to resolve the situation as soon as possible;
 - 2.7.5. it is required to observe all visual signs or prohibitions posted in the territory, including speed limit signs and parking area demarcation signs;
 - 2.7.6. to swim only in a specially designated and marked place for swimming;
 - 2.7.7. to pay for the use of picnic tables and canopies, benches, grill equipment and other paid equipment with 333 staff;
 - 2.7.8. to verify with 333 staff whether the use of a 333 service, attraction or any inventory is a paid or free service. Ignorance does not excuse responsibility;
 - 2.7.9. If the Visitor stays in the 333 territory with a dog, then it must be kept on a leash, and its excrement must be collected. Penalty for non-compliance with the rule is EUR 50,00 (fifty euros);
 - 2.7.10. In the event that the Visitor wants to take photos or film with professional equipment in the 333 territory (including filming with "drone" type equipment), then the Visitor must contact the 333 staff and sign the terms of use of the media.

3. The Visitor is strictly prohibited from:

- 3.1. Bringing weapons, explosive substances, pyrotechnics, sharp objects and any other objects or substances that may harm human health and safety into the territory of 333;
- 3.2. Bringing and using of torches, smoke candles and similar items;
- 3.3. Bringing, using and being under the influence of alcohol, narcotics or other intoxicating substances. The ban on alcohol consumption does not apply to cases where alcoholic beverages are sold in 333 territory during public events;
- 3.4. Behaving inappropriately and loudly in public places, disrupting the order of public events, posting, writing and expressing offensive words and slogans insulting the dignity, nationality and culture of persons;
- 3.5. Verbally or physically abusing the participants of competitions, training sessions, public events, judges, 333 employees and other visitors, as well as disruption of the course of events and training, creating sounds and sound effects that disrupt the work of responsible persons and the course of the event during sports and public events.
- 3.6. Riding a bicycle, moped and other vehicles (skateboards, roller skates, etc.) on the territory of 333 if it interferes with the movement of pedestrians, 333 event and traffic safety, as well as if driving is done aggressively and is disruptive to other Visitors;
- 3.7. Driving of vehicles outside the permitted territory, in particular, in the green zone, including in the forest in the green zone;
- 3.8. In the territory of 333, it is forbidden to use inventory or other leisure equipment, which is not mentioned in the 333 internal rules and regulations of the tracks and facility and the 333 price list, except when coordinated with 333 management;
- 3.9. For the visitor who is a spectator – being on the driven part of the tracks and walking behind a fenced-off area;
- 3.10. Damaging by littering public spaces, 333 territory, throwing away garbage, spitting, attending to one's natural needs in places not intended for it, damaging or moving trail markings, warning and other informational signs.
- 3.11. Attending paid events is prohibited without an entrance ticket;
- 3.12. Smoking in prohibited places;
- 3.13. Drinking of alcoholic drinks by minors;
- 3.14. Placing any sports equipment on a surface that is not covered with carpet, PVC material or other covering that protects the surface from oil or any other chemical products. Penalty for non-compliance with the rule is EUR 300,00 (three hundred euros);
- 3.15. Arbitrarily play any kind of music or sound louder than human conversation;
- 3.16. Climb, clamber on any kind of 333 constructions, buildings, walls, fences, poles and other such type, kind of 333 property, including moving 333 property;
- 3.17. To carry out commercial activities in the territory of 333 without coordination with the 333 administration;
- 3.18. Enter the territory of 333 outside its working hours;
- 3.19. To organize events of an erotic, anti-state or anti-constitutional nature, events related to a disproportionately high, uncontrolled risk to the health and life of persons;
- 3.20. To violate any rules, prohibitions, which apply to any visitor in the territory.

4. Measures in case of emergency:

- 4.1. In an emergency situation, visitors are obliged to notify 333 employees immediately about the incident and, if necessary, call the emergency services;
- 4.2. Visitors must follow the instructions of 333 employees, event organizers and operational/emergency services.

5. Visitor responsibility:

- 5.1. Regarding the observance of obligations and prohibitions, their execution and the resulting consequences, including material losses; the visitor is aware that he/she must also bear responsibility for the damages caused to the procedure of the event, if the Visitor's actions have interfered with the event.
- 5.2. Visitors are personally responsible for their personal belongings and 333 does not assume material responsibility for the material values left on the territory of 333 and the vehicle left in the parking lot. 333 is not responsible for injuries suffered by visitors during training and competitions, or caused by violating the rules of the 333 territory or not following warning signs.
- 5.3. The organizer of the event is responsible for the damage caused as a result of the visitor's actions, disregarding the Rules, the instructions of 333 employees or the persons responsible for the event, the posted warning signs, inscriptions, endangering the health and life of themselves or other visitors, if the damage was caused during the event, as well as the person who caused the damage.

6. Visitor rights:

- 6.1. Staying in the 333 territory in accordance with these and other regulations;
- 6.2. Asking questions related to Visitor status and receiving answers to questions of interest from 333 staff.

7. Processing of personal data

- 7.1. By using the 333 territory, the visitor gives his consent to the 333 administration or its authorized third party to process his personal data, to ensure performance of the services, including providing a secure service. The legal basis for personal data processing is Regulation (EU) 2016/679 of the European Parliament and of the Council (April 27, 2016) On the protection of natural persons with regard to the processing of personal data and the free movement of such data which repeals Directive 95/46/EC (General Data Protection Regulation) and its Article 6, Clause 1, Subsections (a) and (b).;
- 7.2. In order to ensure the safety of visitors, the management of 333 conducts video surveillance for the purpose of prevention and detection of criminal offenses, as well as property protection. The legal basis for personal data processing is Regulation (EU) 2016/679 of the European Parliament and of the Council (April 27, 2016) On the protection of natural persons with regard to the processing of personal data and the free movement of such data which repeals Directive 95/46/EC (General Data Protection Regulation) and its Article 6, Clause 1, Subsection (f) – the manager's legitimate interest in ensuring the safety of its property and visitors;

For the personal data processing objectives in Articles 6.1. and 6.2. of the Regulations, the data processing is carried out by the manager/controller – company SIA "Baltic Ring 333", company reg. No. 40103537133, "Sila Priedes", Ropazi district, LV-2133, Latvia, e-mail for contacting about data processing: info@333.lv, homepage: www.333.lv. Additional information on the processing of the mentioned personal data can be obtained at ://333.lv/privatuma-politika/ or by getting to know it in person in the 333 territory.

- 7.3. 333 management and its authorized third party process the data of natural persons in accordance with the requirements of the General Data Protection Regulation and other regulatory acts.

8. Various questions:

- 8.1. If the aforementioned rules are not followed, the Visitor is given a verbal warning. If the Visitor does not comply with the warning, then being located at 333 is immediately denied (if necessary by calling law enforcement authorities), without the right to restore it, and payment for unused services is not returned;
- 8.2. If the Visitor has any type of disputes or disagreements with any 333 third party, then mutual disputes must be resolved through negotiation, if this fails, the Visitor and a third party settle disputes and disagreements in judicial institutions in accordance with the procedure specified in the regulatory legal acts of the Republic of Latvia;
- 8.3. On providing a service that does not comply with the contractual provisions, the Visitor, if he/she is considered a consumer in the sense of the laws of the Republic of Latvia, can contact the company SIA "Baltic Ring 333", company registration No. 40103537133, "Sila Priedes", Ropazi district, LV-2133, Latvia, e-mail: info@333.lv with a written, justified application. The submission will be considered in accordance with the norms set forth in the Law on the Protection of Consumer Rights [*Patērētāju tiesību aizsardzības likums*]. The service is considered to be in accordance with the terms of the contract if:
- 1) the content of the service, the way it is provided and the result correspond to what was agreed upon;
 - 2) the service is provided with professional care, taking into account the interests of the consumer;
 - 3) the service meets the requirements that are reasonably set for such services;
- 8.4. Visitors are obliged to report violations of the rules to the 333 administration by calling the number: 29555333.
