## **Rules of operation of rental track go-karts**

### **1. General Provisions:**

- 1.1. *The data protection disclaimer hereby confirms that the information and personal data you have submitted in connection with compliance with the rules will be collected, processed and stored in accordance with the requirements of European Union regulations regarding personal data protection. By submitting your data, you agree that the data is processed and stored for the entire period of data processing indicated here, as well as in the cases specified in the regulatory acts after the initial data processing for as long as it would be necessary. The collected data will not be transferred to third parties, except when such an obligation is imposed by regulatory acts. You have the right at any time to request the restoration of your data, information about the use of your personal data, as well as to request the deletion of your data;*
- 1.2. These rules determine the procedure for operating the rental track go-karts of SIA "Baltic Ring 333" (hereinafter referred to as 333).
- 1.3. The rental track go-kart is used by the user of the rental go-kart (hereinafter referred to as the Renter).

### **2. Obligations of the rental go-kart user:**

- 2.1. It is allowed to enter the karting track only with a protective helmet.
- 2.2. The Renter drives only in the indicated direction on the track and in the service (pit) lane.
- 2.3. The Renter drives at a safe distance from another go-kart to avoid a collision.
- 2.4. The Renter must enter the service (pit) area at a safe speed (slow), and drive there at no more than 5 km/h.
- 2.5. It is allowed to enter the track only with the permission of the 333 Track staff and it must be left after the first request of the staff, about which the Renter is informed by the staff – by showing a raised hand or a black and white finish flag.
- 2.6. The driving speed on the track should be chosen according to personal driving skills and abilities, as well as evaluating personal state of health and reaction speed.
- 2.7. In case of stopping, signal with a raised hand and wait for the service personnel.
- 2.8. Useful and available 333 property and issued equipment must be treated with care.
- 2.9. Damages caused to 333 must be covered, if they occurred during the driving session due to the Renter's fault as a result of non-compliance with the operating rules.
- 2.10. The Renter must follow what is happening on the track in front, next to and behind him/her.

### **3. The rental go-kart user is strictly prohibited from:**

- 3.1. Use of the rental go-kart under the influence of intoxicating substances.
  - 3.2. Starting the go-kart arbitrarily and start driving without the permission of the 333 staff.
  - 3.3. Stopping on the track to initiate a "start" from a spot.
  - 3.4. Arbitrarily changing the designated riding direction, configuration and stopping at the track without a reason;
  - 3.5. Causing deliberate collisions with other drivers and with signs demarcating the track.
  - 3.6. At the end of the session, entering the service area at high speed.
  - 3.7. Getting out of the go-kart on the track in the event of a forced stop, except when permitted by 333 personnel.
- 4. Responsibility of the rental go-kart user:**
- 4.1. Regarding the observance of obligations and prohibitions, their execution and the resulting consequences, including material losses.
  - 4.2. Civil liability in accordance with the legal norms in force in the Republic of Latvia.
- 5. User rights:**
- 5.1. Asking any questions and getting answers from 333 staff on interesting and unclear questions related to karting and service.
- 6. Various questions:**
- 6.1. Company SIA "Baltic Ring 333" does not take responsibility for the Renter's personal material values;
  - 6.2. In case of non-compliance with the above-mentioned rules, the User is given a verbal warning, if the User does not follow the given warning, the User is immediately denied participation in the driving session, without the right to renew it and the payment for the lesson is not returned. 333 staff has the right to remotely limit the maximum driving speed of the rental go-kart for the User if he/she violates the operating rules of the rental go-kart.
  - 6.3. On providing a service that does not comply with the contractual provisions, the User, if he/she is considered a consumer in the sense of the laws of the Republic of Latvia, can contact the company SIA "Baltic Ring 333", company registration No. 40103537133, address "Sila Priedes", Ropazi district, LV-2133, Latvia, e-mail: info@333.lv with a written, justified application. The submission will be considered in accordance with the norms set forth in the Law on the Protection of Consumer Rights [*Patērētāju tiesību aizsardzības likums*]. The service is considered to be in accordance with the terms of the contract if: 1) the content of the service, the way it is provided and the result correspond to what was agreed upon. 2) the service is provided with professional care, taking into account the interests of the consumer. 3) the service meets the requirements that are reasonably set for such services.
  - 6.4. If the User has any kind of disputes or disagreements with the staff of SIA "Baltic Ring 333", then mutual disputes must be resolved through negotiations, if this fails, in order to resolve the situation, then the parties resolve the disputes and disagreements that have arisen in the judicial institutions in accordance with the procedure specified in the regulatory legal acts of the Republic of Latvia, with the Republic of Latvia as the jurisdiction.
  - 6.5. The user has familiarized himself with the "Rules of operation of rental track go-karts", fully understands them and undertakes to comply with them, which he confirms with his signature.
